We are delighted to offer our children's membership scheme, which enables us to provide your family with the treatment and support necessary to control dental disease and restore their mouth to full fitness.

## Level 0 (ages 0-5 years)

Free to children whose parents regularly attend the practice

*Regular dental examinations to provide:*

- Clinical examination every six months.
- Dental treatment with the dentist or therapist.
- Diet and preventive advice.
- Topical fluoride application.

## Level 1 (ages 6-11 years) £4.70 per month

*Regular dental examinations to provide:*

- Clinical examination every six months with a dentist.\*
- Diet and preventive advice.

*Dental pain:*

- Assessment of emergencies and dental pain during normal surgery hours.

*Preventive advice and treatment:*

- Preventive advice, fluoride application, tooth brushing instruction and any scaling required.\*

*Dental treatments:*

- Should dental treatment be required, child treatment fees apply.

*Worldwide Dental Emergency Assistance Scheme\*\**

- Eligibility to request assistance following a dental trauma and/or dental emergency or oral cancer.

## Level 2 (ages 12-17 years) £6.80 per month

Children under this plan will receive the same benefits as those on Level 1, but with the added benefit of x-rays included under the monthly cost (when necessary). There will also be an annual visit with hygienist/oral health educator.\*

## How Do They Register?

\*\* The Worldwide Dental Emergency Assistance Scheme is a scheme established to offer support and assistance to dental plan patients who request treatment following a dental trauma and/or dental emergency or oral cancer. The Scheme responds to requests for assistance on a wholly discretionary basis. This means that, whilst the Scheme aims to provide benefits in most cases, it has no obligation to provide any benefit unless it first decides (in its sole and absolute discretion) that it should provide a benefit. There are some circumstances in which the Scheme is not designed to help and these are explained in more detail in the Scheme Handbook. Each request will be looked at individually to assess the request for benefit. Certain restrictions and limitations may apply in the event that the request is accepted and it is possible that the Scheme will decide to provide no benefit.
